- 1 Non Refundable Tender Fees Rs. 1000 /-
- 2 Only the Successful tendree will be intimated telephonically or by mail.
- 3 You will get the required permission from Drug licence authority.
- 4 You have minimum 5 year experience of running Medical Store with minimum 5.00 crore yearly sales.
- 5 The University will get the Caution Money Deposit Rs. 500000 /- from Successful tenderee.
- 6 You will obtain requisite appraoval / license from the Regulator for setting up medical store and ensure that the approval & license are renewed from time to time so as to retain its validity. Similarly , you will obtain all other Registrations as may be applicable e. g. VAT Registraton etc.
- 7 You will appoint qualified full time pharmacist staff, to ensure that the patient / relatives of patients do not have to wait for unnecessary long time to get the medicine.
- 8 You will maintain adequate stock of all type of generic medicines 24X7. You have to ensure that patients / relatives of patients do not have to face any inconvinience. In an un forseen event of particular medicines not being available, you will arrange to get it in maximum with in 3 hours at your own cost by deputing your representative to near by city of Vadodara.
- 9 You will supply medicines required by the Hospital attached with this University on cost to cost basis without any ceiling of single purchase or aggragate purchases by the Hospital. And reasonably discount pass to all patient / relatives of patient. Committee will audit of this transaction. if found any discription , contract will autometically cancelled.
- 10 You will keep track of expiry date of medicines and ensure that you do not keep stock or supply medicines to patients for which the expiry date falls in next two months.
- 11 You will keep the store open for 24 X 7 with presence of pharmacist.
- 12 The University shall have absolute right to establish one or more medical store with in the campus.
- 13 The right to use is conferred to you subject to condition that it will be used only for medical store and not for other purpose.
- 14 The right of use conferred to you is non transfarable. Moreover considering the paculier nature of arrangement requiring fullfilment of special obligations on your part , you will not enter into any partnership or take any partner.
- 15 It will be your responsibility to esure that genuine medicine are sourced, stored and dispensed. You will make a proper arrangement to store the medicine in cool enviorment away from sunlight.
- 16 It will be your responsibility to maintain highest standard of clinliness in the store in its surrounding area. You will make arrangement arrangement proper disposal of solid waste.
- 17 You will not sell or deal with any item other than the medicines and related products.
- 18 You will keep necessary number of fire extinguisher in the store as a protection against fire.
- 19 You will be indemnify the University for damage to property or its surrounding area.
